2 BUSINESS ARISING

2.01 Registered Apprenticeship Program (RAP)

Superintendent Morrison shared the Registered Apprenticeship Program (RAP) action plan, developed in consultation wit the high school RAP coordinators.

- Identify work experience settings that are RAP eligible and use initial work
 experience hours as a starting point for RAP. If the student is in Grade 12
 assist them with RAP paperwork at the end of the year for registration as a
 returning Grade 12 or facilitate an apprenticeship placement for the year
 after Grade 12.
- Give every student the RAP brochure from the Government of Alberta website as part of their registration, post-secondary, and career planning process for Grades 10, 11, and 12. Highlight the apprenticeship pathways from the brochure.
- Use social media to promote student placements in RAP.
- Develop a call for RAP employers in both a direct email to parents and through a social media post.
- Inform students about RAP scholarships available in the province.
- Ensure RAP coordinators are aware of the process and forms to facilitate a RAP placement by bookmarking the Apprenticeship and Industry web page.
- Prepare counselors to counsel RAP students regarding academic requirements.
- Book three separate Divisional Careers: The Next Generation presentations for all CTR Catholic students.

Trustee de Jong (Brooks) questioned whether an in-depth promotion of RAP had ever been done in CTR Catholic before to which Dr. Morrison responded that it hadn't. Superintendent Morrison stated that the career counsellors in the high schools are very excited about opening up these doors for students. Dr. Morrison noted that the social media promotion will begin in February and counselors will begin their work with students in March. Trustees were very appreciative of the plan to promote RAP throughout the division.

The Board requested an update at their June 24, 2021, Board meeting.

10 ALBERTA CATHOLIC SCHOOLS TRUSTEES' ASSOCIATION

10.01 ACSTA Directors' Meeting and AGM Update

Trustee de Jong (Brooks) reported that ACSTA received good feedback on the panel discussion at the AGM which gave an interesting perspective on the Mission Collaborative Initiative. Trustee de Jong (Brooks) noted that the bishops are not worried about outside influences taking Catholic education apart as they feel if it happens it will come from within. Catholic school divisions must be authentic through their trustees, teachers, and service.

Trustee de Jong (Brooks) highlighted the following from the last ACSTA Directors' meeting:

- The ACSTA Executive have hired an assistant for the Executive Director.
- The ACSTA Board is still committed to 21 members.
- Grace Director, Dr. Bonnie Annicchiarico, will be invited to ACSTA meetings once a year, which is very positive.
- The Board has decided to administer survey questions to school divisions regarding GrACE. CTR Catholic will set aside time at their January 2021 Board meeting to complete the survey.
- The ACSTA is in the process of doing a Board self evaluation.
- The Executive Director recommended the following book, which is germane to Catholic Education: Trial: The Loss of Constitutional Rights in Education in Newfoundland and Labrador and The Six Secrets of Change.
- ACSTA will put out a pamphlet for trustees looking for re-election.

- The Theodore case is still on hold.
- ACSTA will be meeting with the Ministry before they respond to CTR Catholic's letter.

11 ALBERTA SCHOOL BOARDS ASSOCIATION

11.01 ASBA Zone 5 Report and FGM Update

Vice Chair Keenan (Foothills County) reported that the FGM was a success despite some technical difficulties. Trustee Van Donzel (High River) stated that she was happy to have the proposal to include indigenous languages accepted by Second Languages Caucus. Chair Schreiber (Okotoks) noted that he was pleased with the outcome of the meeting and lobbying points going forward.

Vice Chair Keenan (Foothills County) highlighted the following from the last ASBA Zone 5 meeting:

- Elections were held. Fiona Gilbert from stepped down as Zone 5 Chair.
- The new Zone 5 Chair is Jennifer Mertz from Golden Hills, the new Zone 5
 Vice Chair is Theresa Letendre from Foothills School Division, and the Zone
 5 Alternate Director is Rob Pirie from Golden Hills. All other committees
 have retained the same members.
- In her last report Fiona Gilbert stated that she was happy with how her term went and all the work and cooperation of members in Zone 5.
- ASBA Board of Directors reported that in an effort to increase efficiency and transparency for external board appointments a skill set matrix and term limits for external board appointments were agreed upon. There will be a 2-year term limit with a maximum of 2 consecutive terms for all external committees with the exception of government sponsored groups. They are still working hard on advocacy initiatives and meeting with education stakeholders and the Education Ministry.
- Ron Taylor addressed a concern with "missing students". They are not sure if they are missing due to COVID-19 as they have not registered. There is a group in Edmonton who manage data on registrations through PASI so the government is aware that they are missing from the counts. Some schools still have not submitted their data so there is nothing official to share. With COVID-19 a lot of school boards want more tracing, and a faster response for parents to see what cases there are in the schools. They are working as quickly as they can to remedy this. Dr. Hinshaw has updated the daily check list for students.
- In the afternoon there was a professional development session on Governance Foundations.

12 DIVISION

12.01 Superintendents' Reports

Chair Schreiber (Okotoks) asked trustees to detail what particular items should go into Board Highlights following each Superintendent's report. Executive Assistant Aileen Brunette reviewed newsletters statistics with Board members.

Associate Superintendent Behm reported on the following:

- Wellness across the division and the need for social connection. CTR
 Catholic focused on administrators' wellness and self-care, discussing
 how their workload has increased or changed.
- CTR Catholic's retirement statistics and a webinar to assist them in planning for it. The webinar consisted of an overview of the retirement transition program, resources available, substitute teaching, and short-term opportunities
- Support staff and teacher absences noting that longer term absences are well above what they were last year.
- The failure to fill report on substitute teachers in schools.

Trustees selected an item for Board Highlights as follows: the focus of CTR Catholic on the wellness of the staff and administrators due to COVID-19.

Associate Superintendent Kilcommons reported on the following:

- CTR Catholic's insurance challenges.
- Update on a legal issue with a contractor.
- Transportation challenges and successes due to COVID-19.
- Update on the Okotoks Arts and Learning Campus which is still on schedule and under budget.
- Update on replacement structure for École Good Shepherd School Gymnasium.

Trustees selected items for Board Highlights as follows: insurance challenges and trustees reaching out to their local MLA's for support; transportation department being able to continue to get students to schools in light of difficulties with COVID-19; and CTR Catholic working with Southland Transportation to continue the employment of bus drivers.

Associate Superintendent Moss reported on the following:

- The number of positive cases of COVID-19 in the division as of November 27th, with a breakdown of schools affected.
- COVID-19 fire drill with administrators to prepare them for learning disruptions, which included reflections from four principals on how they have dealt with having a positive case in their schools with the use of live streaming and a testimony of a Grade 1 teacher who live streamed with her class while self isolating.
- Students will have the option to write their Grade 6 and 9
 Achievement Tests and Grade 12 Diploma Exams, but CTR is not administering these exams unless explicitly requested by students/parents. Automatic exemptions will be applied for students who choose not to write. A teacher developed final exam may be given in all core courses.

Trustees expressed their thankfulness that CTR Catholic has been prepared for live streaming since the beginning of the pandemic.

Trustees selected an item for Board Highlights as follows: COVID-19 fire drill and the fact that CTR Catholic was prepared with a plan in place.

Superintendent Morrison reported on the following:

- Communication after announcement by Premier included:
 - For Grades 7 to 12 there will be regularly scheduled live streaming or a comparable alternative, full curriculum instruction and assessment, a plan for academic neglect, educational assistant support, some special needs students allowed into the school, and devices loaned out.
 - For the week following Christmas CTR they will loan devices to Grades K to 6 students needing them and there will be reduced workload and screen time.
 - All personnel at schools in Grades K to 12 will be working from their school before Christmas and then working at home for the first week back after Christmas (January 4 to January 8). The Centre for Learning @ Home and Catholic Education Centre staff will also work from home the week of January 4 to January 8.
- CASS collaboration is very beneficial as it allows school divisions to know what they are all doing. Zone 5 superintendents had a host of

similarities in their at-home delivery plans and these include: regular schedules, interactive teaching, technology assistance, staff work out of their school, special needs students to be served, substitute teachers engaged, and increased staff precautions. Vincent Behm and Cheryl Kuemper have both been identified as Thought Leaders for CASS Zone 5.

- Attendance tracking observations with a review of the percentage of absenteeism per school for the last week.
- Discussed team excellence and commended all superintendents for their excellence.

Associate Superintendents Behm, Kilcommons, and Moss recognized Superintendent Morrison's leadership of CTR Catholic including his vast knowledge of the division, his superior management skills, his vision and high expectations for CTR Catholic, his habit of giving other people credit when it was he who did the work, and the fact that he is so well respected in CTR Catholic and the bigger community.

Trustees selected an item for Board Highlights as follows: The excellence of the Superintendent and his team, including CTR Catholic's administrators, teachers, and support staff. Chair Schreiber indicated he will write the article.

12.02 Program Review Update

15 NEW BUSINESS

15.01 Presentation of Budget

Associate Superintendent Kilcommons reviewed CTR Catholic's audited financial statement for the year 2019-2020 highlighting that the auditor's testing of internal controls did not reveal any significant deficiencies. Mr. Kilcommons reported that the division ended up with a surplus of approximately \$85,000 and has accumulated discretionary operating reserves of \$4,000,000. Mr. Kilcommons addressed the budget for 2020-2021 which was approved by the Board on June 10, 2020. Projections for enrolment, staff, and all expenses were submitted in March 2020 for final budget analysis with a projected deficit of \$295,000. Variables that will require in year adjustments and will be reflected in the 2020-21 financial statement as of August 31, 2021 include: May 2020 Capital Maintenance and Renewal monies; September 30th

enrolment update; Federal stimulus 1 and 2; and insurance premiums. Associate Superintendent Kilcommons advised trustees that he received confirmation from the government on November 26th that they will be allocating CTR Catholic \$1,199,623 to fund the property insurance premium increase of \$1,200,000 which was great appreciated.

Discussion with trustees followed on CTR Catholic's insurance premiums, the legal issue in Drumheller, the new joint school site with Foothills School Division in the Town of Okotoks, and the appraisal of land in the Montrose area of High River.

15.10 November 12, 2020, Regional Planning Meeting Report

Vice Chair Keenan (Foothills County) and Chair Schreiber (Okotoks) attended a meeting of the Regional Planning Committee comprised of representatives from CTR Catholic, Foothills School Division, Franco Sud, the Town of Okotoks, and County of Foothills on November 12, 2020. This regularly scheduled meeting is a fine example of various municipalities working together to seek the best solutions to arising issues. Highlights from the meeting included an update on the construction of the Arts and Learning Campus which is a joint project that CTR Catholic is undertaking with the Town of Okotoks. The work is going well and is about 3 weeks ahead of schedule. As well, Town representatives pointed out that the Town is reviewing its Municipal Development Plan and Land Use Bylaw. This is an apt time to potentially incorporate changes that could have substantial effects on the construction and modernization of schools in the community and members were encouraged to take part in an upcoming Town-sponsored webinar on the Land Use Bylaw held November 17th. Chair Schreiber (Okotoks) and Associate Superintendent Kilcommons both attended the webinar and were able to provide input reflecting the perspectives of CTR Catholic which will be considered in the development of the new Land Use Bylaw.
