2 BUSINESS ARISING

2.01 Catholic Education Program Review - Update

Superintendent Morrison confirmed Jennifer Woo has agreed to conduct the Catholic Education Program review. She will develop the scope within the five broad areas provided to her. Associate Superintendent Moss will work with Ms. Avramovic (Director of Catholic Education) to facilitate school visits when the time comes. The review is being conducted with the Bishop's blessing.

2.02 École Good Shepherd School Gymnasium – Update on Letter to Minister Chair Keenan (Foothills County) shared that she had contacted the Minister's office for an update on the letter submitted regarding the École Good Shepherd School Gymnasium. She was advised that the letter had been received and that a response was still pending. Trustees requested Chair Keenan continue to follow up with the Minister's office.

2.03 Community Influencer Engagement Superintendent Morrison suggested that prior to the Board conducting the community influencer engagement that a test run be conducted with the School Council Chairs at the Council of Councils meeting on May 18, 2022. The purpose of this is twofold in that Trustees become familiar with Council Chairs and Council Chairs become familiar with the process.

It was the will of the Board to conduct the influencers engagement at the Council of Councils meeting scheduled for May 18th.

2.04 Draft Capital Reserve Budget

Associate Superintendent Kilcommons reviewed the draft capital reserve budget with the Trustees. The final capital plan will be presented in May and will be included in the Four-Year Education Plan.

Feedback and comments are welcome at the next Board meeting if they arise.

2.05 Media Training

Cindy Nickerson (Coordinator of Communications) reviewed details of the media training that the Board will undergo at their Committee of the Whole meeting on March 25th, 2022. This training will benefit the Trustees in their communication with media, school councils and community members.

FOUR YEAR EDUCATION PLAN

Trustee Liedtke (Canmore) highlighted the following from CTR Catholic's four pillars, as they pertained to the Canmore Ward Committee meeting:

Carried

Faith: Father Nathan commended the school for quality of the students' questions when he guest speaks in classes. He said the students aren't asking about typical controversial issues and instead asking more spiritually deep questions such as "how should I feel when I pray" and "what are the religious ethics pertaining to our school's genetic engineering project"?

Learning: Our Lady of the Snows outperformed the province on every measure of achievement on the recent Assurance results. Of special note, was Our Lady's citizenship satisfaction, which was 10% higher than that of the province.

Safe and Caring: The Parent Council is focusing on both staff and student wellness, supporting the staff with regular appreciation activities and providing various student programs, such as sports, bands, and clubs, with resources.

Stewardship: Facility issues are a main concern. The province has announced the third successive delay in the installation of Our Lady's new modular classrooms, there is no land available to build a new school, and there seems to be little indication that the Town of Canmore has a plan to secure school sites in the near future.

Stewardship: The School Council is actively working on the structure of St. Anthony's Influencers engagement in the community, and this is the type of focus CTR encourages all School Councils to adopt.

11 ALBERTA SCHOOL BOARDS ASSOCIATION

11.01 ASBA Zone 5 Report

Vice Chair Salm (Strathmore) provided information from the February 4, 2022 ASBA Zone 5 meeting, including information regarding chartered schools. It was noted that the Board in the past has supported charter schools, because it is in favour of school choice.

11.02 Provincial Government's 20-Year Strategic Capital Plan

Vice Chair Salm (Strathmore) provided the Provincial Government's 20-Year Strategic Capital Plan to the Board. The Plan is not restricted to education and has details on all infrastructure within the province. It includes support for multiple entities working together to achieve more efficient use of funding and spaces. The only such possibility of this within CTR Catholic's system is a designated school site in the new D'Arcy Ranch development which would have potential for shared spaces with Foothills School Division.

ASBA will be meeting with the Minister of Education on March 5th. Trustees were canvassed for possible discussion topics for that meeting, some of which were utilization of additional funding received, the Minister's proficient handling of Covid restrictions, the direction and leeway provided by the Ministry regarding the lifting of the mask mandate, and openness to input regarding the new curriculum.

This conversation brought forth the suggestion of inviting the Minister to the Board's March or April meeting. The Trustees agreed unanimously to extend an invitation in this regard.

Another topic of interest for the March 5th ASBA meeting will be how each school division supports School Councils.

12 DIVISION

12.01 Trustees to identify one feature from each Superintendent's Report for the Board Highlights

12.02 Superintendents' Reports

Chair Keenan (Foothills County) reminded Trustees to identify one feature per Superintendent report for the February Board Highlights.

Superintendent Morrison reported on the following:

- In an effort to improve services to families, Associate Superintendent Moss and her team are exploring the development of a licensed Pre-K program as well as a third-party before and after school care program.
- Priorities for next year have been identified as 1. Faith will continue to focus on we are many and we are "one" and living the way, the truth and life; 2. Learning including team-based praxis, confronting learning loss, new curriculum, early literacy and numeracy, Readers and Writers Workshop, as well as coding in an invitational manner; 3. Safe and Caring including healthy schools, universal mental health supports; and 4. Stewardship assessing risks including the potential enrollment decline at the CFL that could occur as in-class learning returns.
- CTR Catholic will experience an unprecedented number of new administrators within the system next fall. To ensure quality leadership, a process to calibrate the performance of all new administrators using a centralized focus group method and existing methods such as collegial mentorship will be introduced. This will allow new administrators to share and learn from experiences as they occur.

It was the will of the Board to highlight the exploration of Pre-K programming and before and after school care as well as the mentorship program being introduced

for administrators from Superintendent Morrison's report in their February Board Highlights.

Deputy Superintendent Behm reported on the following:

- Two-factor authentication for Office 365 all schools except for one have completed implementation. Implementation was successful and well received by staff. It has not yet been implemented for substitute teachers. Two-factor authentication will become active in the next three weeks.
- ASEBP is CTR Catholic's benefit program provider and partners with Homewood Health for support and resources to employees. CTR Catholic has a high rate of access to supports and services which is a sign of positive organizational health. Details of utilization of services were reviewed.
- Liaison Committee the next Committee meeting will be held in March. The Board discussed possible agenda items.

It was the will of the Board to highlight health support services for staff from Deputy Superintendent Behm's report in their February Board Highlights.

Associate Superintendent Moss reported on the following:

- Covid-19 update schools are seeing a decline in student absentee rates in February. Principals are seeing very few students wearing masks since the change in provincial regulations. Plans have been made in anticipation of the remaining restrictions being lifted on March 1st.
- International Day for the Elimination of Racism and Discrimination CTR
 Catholic's Many and One Initiative is pleased to have Aubrey Noronha
 presenting to students and parents on March 21. The presentations will be
 tailored to different age groups. Trustees are welcome to attend these
 sessions.
- Spring Council of Councils Meeting will be held on May 18, 2022. Possible topics for the meeting were reviewed, including Community Influencer Engagement, Community Conversations and St. Joseph's Parent of Distinction Awards.
- Two Superchats have been held in February École Good Shepherd and St. Francis of Assisi Academy. A summary for each of these meetings was provided.
- A transition plan has been formulated to bring in Pat MacDonald in her new role as Associate Superintendent. She will shadow Associate Superintendent Moss for May and June.

It was the will of the Board to highlight Aubrey Noronha's presentations for International Day for the Elimination of Racism and Discrimination from Associate Superintendent Moss' report in their February Board Highlights.

Associate Superintendent Kilcommons reported on the following:

- School-site based operating budgets each school is allocated an operating budget based on a per-pupil basis. Budget spending is monitored monthly, and on average schools have spent only 47% of their allocated operating budget. This is because principals have been prudent in spending.
- Furniture and equipment/technology purchases for 2022-2023 the deadline of March 15th, 2022 has been given to principals to submit their requests. This deadline is earlier than usual but will allow for more efficiency in ordering and will better ensure that items are received for fall.
- BMO (Spend Dynamics) has advised that they will be implementing twofactor authentication as of March 14th. Details and instructions on implementation will be provided shortly.

It was the will of the Board to highlight prudent spending by principals from Associate Superintendent Kilcommons' report in their February Board Highlights.

12.03 Board Approval of 2022-2023 School Calendars

Deputy Superintendent Behm advised that development of the school calendars is governed by Board Policy #27 and provisions set out by Alberta Education. The proposed calendar was reviewed. Trustees agreed that the staggered entry should be alternated annually between the two student groups designated by surname.
