Dr. Morrison reviewed the number of students registered at each high school. The initiative to expand RAP has been successful in part due to the advertising CTR did to find employers.

3 FOUR-YEAR EDUCATION PLAN UPDATE

3.01 Summer Math PD Plans

Associate Superintendent Moss introduced Director of Learning, Cheryl Kuemper, who will be leading the math professional development summer work. Director Kuemper shared with trustees what the teacher professional development will look like, highlighting the benefits of piloting, the development of curriculum support documents, CTR's partnership with Pearson and their Mathology resources, and next steps.

Trustees discussed the sharing of curriculum support documents produced by CTR's teachers, Alberta Education's financial support for teachers attending PD, and the teacher workload when all six curriculums are implemented in 2022. Trustees were appreciative that CTR's teachers are cooperating with the new curriculum. Associate Superintendent Moss stated that teachers were supportive due to Director Kuemper's relationship with them for which CTR is very fortunate.

7.01 ACSTA Directors' Meeting Update

Trustee de Jong (Brooks) reported that ACSTA is looking at providing a session to train new trustees. Chair Schreiber (Okotoks) noted that he completed an ACSTA survey on new trustee orientation and asked individual trustees to do the same. 8 ALBERTA SCHOOL BOARDS ASSOCIATION

8.01 ASBA Zone 5 Report

Chair Schreiber (Okotoks) highlighted the following from ASBA's recent meeting that he attended on behalf of Vice Chair Keenan (Foothills County):

- The budget was discussed, and it was decided to leave it as is.
- Their handbook and operating procedures are up for review.
- ASBA is looking at taking on banker board duties.
- They are digitizing their information and records.
- It was suggested that there be compensation standards for committees.
- The Alberta Education representative spoke about the vaccine rollout, FOIP, and the importance of graduation ceremonies for Grade 12 students.

Chair Schreiber (Okotoks) gave a brief update on the TEBA meeting held on June 17th. A presentation from two labour lawyers regarding strategies stressed the value of relationships.

8.02 ASBA Spring General Meeting Insights

Vice Chair Keenan (Foothills County) reported that the Spring General Meeting was well organized but ended up being quite long due to emergent policy discussions. Chair Schreiber (Okotoks) shared the tabulated results with the Board.

Trustee Van Donzel (High River) attended the second day that focused on professional development. Presentations and models are online until July 2nd, which she encouraged trustees to view as there were some great speakers who are very renowned in the education field.

8.03 ASBA Zone Languages Committee Report

Trustee Van Donzel (High River) gave a slide presentation on the ASBA Zones Language Representatives Committee which she has been on since 2002 highlighting their history and mandate, the work done to date, what it entails to be a Zone Language representative, and the importance of language education.

Trustee Van Donzel (High River) thanked the Board for the opportunity and support in pursuing this work with ASBA.

9 NOON PRAYER AND GRACE

Vice Chair Keenan (Foothills County) led the group in the Afternoon Opening Prayer.

11 DIVISION

11.01 Trustees to Identify One Board Highlight Feature Per Superintendent Report Chair Schreiber (Okotoks) reminded trustees to identify one feature per Superintendent report for June Board Highlights.

11.02 Superintendents' Reports

Associate Superintendent Moss reported on the following:

- Gave an update on COVID in the division as of June 23, 2021.
- Reviewed the results of CTR's mental health survey which will be shared with teachers at the division's professional development in August. The survey was done to get a better understanding of current mental health of students.

- Reviewed the agenda for CTR Catholic's Opening Mass and Divisional PD day.
- Informed trustees of two new team leaders for off-campus education and post-secondary education, who will work together to support CTR's counsellors.
- Informed trustees that CTR has been invited to submit 5 teachers to a
 Grade 11 to 12 curriculum working group who have an interest in science,
 math, and physical education.

Discussion on the opening mass being held during the August professional development took place. Numbers are limited due to the community mass being held.

It was the will of the Board to highlight the new post-secondary and off-campus education team leaders from Associate Superintendent Moss' report in their June Board Highlights.

Associate Superintendent Behm reported on the following:

- Reviewed the statistics on the wellness newsletters. It was brought to
 Associate Superintendent Behm's attention that resources from ASEBP and
 Homewood Health lack a faith element, so going forward they are going to
 make the first article in the newsletter a link to pastoral and health care
 resources from the Diocese of Calgary.
- There will be additional funds from the government to support students in Grades 1 to 3 in the 2021 2022 school year who are experiencing difficulties due to learning disruptions from COVID with an emphasis on intensive literacy and math support. Associate Superintendent Behm reviewed CTR's assessment results on students in Grades 1 to 3 with trustees. CTR has a plan going forward with their educational assistants to provide support to students.
- Reviewed a division profile of summer school enrolment from last year to the current year noting that CTR is up almost 400 students. CTR's goal this year is to be more accommodating for their students due to COVID.
- Gave an update on recruitment and retention of staff.
- Gave an update on new teacher orientation and new teacher induction noting that CTR is changing their normal practice this year in that they will emphasize the leadership quality standard needed when a teacher steps forward for mentorship.

It was the will of the Board to highlight new teacher mentorship from Associate Superintendent Behm's report in their June Board Highlights.

Associate Superintendent Kilcommons reported on the following:

- Gave an update on CTR's budget which will be given final approval in November.
- Discussed the modular classroom situation in CTR.
- Updated trustees on the move to the new Catholic Education Centre.
- CTR will be promoting a risk-intelligent culture through their affiliation with ARMIC (Alberta Risk Managed Insurance Consortium).
- Reminded trustees that their per diems and mileage are to be done by the end of August.

Trustees discussed modular classrooms in Brooks, where it was preferred to have permanent construction, although CTR is not on a short list for construction in Brooks.

It was the will of the Board to highlight ARMIC (Alberta Risk Managed Insurance Consortium) from Associate Superintendent Kilcommons' report in their June Board Highlights.

Superintendent Morrison reported on the following:

- Updated the trustees on the generative work being done by the Calgary Diocese Schools Leadership Team.
- Updates trustees about CASS organizing a system to gather feedback on the draft curriculum derived from the field.
- Updated trustees on graduation ceremonies throughout the division.
- It has been suggested to perform a smudging at the blessing of the new Catholic Education Centre. Discussion followed and trustees were supportive.
- Discussed the current enrolment at The Centre for Learning@HOME, noting that numbers are very strong and should meet projections.
- Reviewed communication plans for the newly purchased parent/staff
 notification system, the promotion of the new facility for St. Luke's Outreach
 Centre, and CTR's robust teacher supervision and evaluation which gives the
 public confidence teachers are being evaluated and is tied to CTR's Four-Year
 Education Plan.

Trustees mentioned that the Liaison Committee has contributed to the success of the teacher supervision, evaluation, and growth.

It was the will of the Board to highlight Calgary Diocese Schools Leadership Team from Superintendent Morrison's report in their June Board Highlights.

12 INTERNATIONAL FIELD TRIPS

12.01 International Field Trips

There were no international field trips brought forward for approval due to the ongoing pandemic and the Board's current ban on field trips. Associate Superintendent Kilcommons stated that there have been some general requests and his response has been that nothing will be brought to the Board until CTR has clear direction from provincial and federal governments on international travel.
