#### 2 BUSINESS ARISING

2.01 Registered Apprenticeship Program

Superintendent Morrison reviewed results from surveys conducted with school coordinators on the Registered Apprenticeship Program (RAP). Superintendent Morrison noted that school counsellors unanimously support RAP, but survey results show there is not a demand from students, there is a lack of willing employers, and schools are not promoting the program.

Discussion on the data presented by Superintendent Morrison and trustees' expectations regarding the future of RAP followed. Trustee Van Donzel (High River) feels it is important that students know what options are available for them after graduation as when they are not academic doors close for them. Vice Chair Keenan (Foothills County) stated that there is an element of students finding themselves after graduation so many don't commit to university or a trade. Suggestions from trustees included dialoguing with shop teachers to get their input on how to enhance RAP, students gaining employment with an employer that would pay for them to attend trade school, and involving families with exposure to RAP such as at parent teacher interviews. Superintendent Morrison stated that CTR Catholic offers career and post secondary counselling at all of their high schools, beginning in Grade 10, showing students as many opportunities as possible.

Barriers to RAP were discussed. Students need to have a car to get back and forth to their worksite, which can be a financial burden. RAP is a big investment in that students have to choose and commit to a career at a young age.

Superintendent Morrison discussed CTR Catholic strategies to promote RAP as follows:

- share resources with students,
- promote Careers: The Next Generation program, and
- recruit employers willing and able to take on apprentices through Facebook, mass email, phone a friend, and stories in local media.

Superintendent Morrison stated that CTR counsellors will be focusing on RAP in their next few divisional Catholic Learning Community meetings.

2.02 Catholic Education Sunday Collection

Chair Schreiber (Okotoks) noted that, in conversations with their Catholic counterparts in the southern region of Alberta and Bishop McGrattan, CTR Catholic agrees that this is a bad time to ask parishioners for a second collection. The Board discussed the idea of CTR Catholic asking its stakeholders to give more to the church on Catholic Education Sunday.

Superintendent Morrison informed trustees that at the November Board meeting they will be approving CTR Catholic's Combined Annual Education Results Report and Three Year Education Plan, which will look exactly as it did last year, with only comments on results updated.

### 11 ALBERTA SCHOOL BOARDS ASSOCIATION

11.01 ASBA Zone 5 Report

Vice Chair Keenan (Foothills County) reported that ASBA Zone 5 met on October 2<sup>nd</sup> by Zoom and highlighted the following:

- Fiona Gilbert will not let her name stand for an executive position this upcoming year.
- The Annual General Meeting for Zone 5 will include the election of a Chair, a Vice Chair, and an alternate Zone Director.
- The Fall General Meeting will be held virtually in November over a two day period.
- Alberta Education reported that they are still working with Alberta Health Services to problem solve any COVID related entry plans.
- School boards' Annual Education Results Reports are due to the Ministry by November 30<sup>th</sup>.
- The Ad Hoc Committee presented on operating procedures. Discussion included clarifications and suggestions for changes in wording.
- Special meetings were held to discuss CASS professional status. The Board of Directors are creating two motions to present to the membership. The Deputy Minister indicated that he'd like to see suggested wording by ASBA as it is related to legislation.
- Policies have come out for the Fall General Meeting.

Vice Chair Keenan (Foothills County) requested that the meeting move In Camera to discuss a legal issue.

### 12 DIVISION

12.01 Superintendents' Reports

Associate Superintendent Moss reported on the following:

 Updated trustees on CTR Catholic's re-entry plan and going to more virtual meetings after learning at the beginning of October that teachers should not form their own cohorts.

- CTR Catholic has had 2 positive cases of COVID, one in an elementary school and one in a high school. The high school case was more complex due to the nature of high school cohorting.
- Currently there are 80 students across the division that are live streaming.
- Promotion of Catholic Education Sunday throughout the division.
- The Diocesan schedule for Fully Alive which are family life lessons.
- The administrators' anti-racism/discrimination working group has heard from Lance Dixon on Courageous Conversations: Talking about Racial Equity in Schools. Mr. Dixon has already spoken to the English Language Learner lead teachers, the First Nations, Métis, and Inuit working group, administrators, and will be presenting at the Bishop's luncheon.
- They are encouraging parent council members to complete the ASCA parent survey on re-entry and COVID which is open until November 6<sup>th</sup>.
- Discussed the plans for the administrators' and trustees' faith retreat in March 2021. The focus of the retreat would be on how to live *The Way, The Truth, and The Life*. Due to space limitations with COVID and restrictions on spacing, the retreat will be broken into two groups and two dates (March 23-24 and March 30-31). The thought is to have the trustees join with principals for one of the dates and vice-principals and senior administrators attend the other date. Discussion followed on dates with most trustees being flexible. Trustees were all supportive of attending with the principals.

### Superintendent Morrison reported on the following:

- After analyzing CTR Catholic's results, the four targeted areas for the new Four-Year Education Plan will be: Diplomas and Achievement Tests, Safe and Caring Schools, Parental Involvement, and Transition to Post-Secondary.
- Superchats at schools this year will focus on gaps in learning. They will engage teachers in what the needs are to help develop CTR Catholic's Four-Year Education Plan.
- Reviewed a spreadsheet showing weekly COVID related absences at schools.
- Chief Superintendents, Bishops, and Directors of Catholic Education will meet three times a year.
- Generative work that CASS has done that is beneficial for education include:
  - treating substitute teachers equitably,
  - reviewing the impact of a positive COVID case in schools and the changing consequences,
  - o the promotion of Careers: The Next Generation.
- Superintendent Morrison has co-authored an article in the CASS Connection magazine.
- The status of provincial achievement tests and diploma exams.
- St. Mary's Board of Governors has partnered with Calgary Diocese school divisions and they will meet twice a year.
- CTR Catholic's principals get supervised every four years. It is a rigorous process that his entire team assists with.
- COVID inspired considerations such as inclement weather paradigm, possibility of continuing with staggered entry, entry doors, online competition, online meetings, and online professional development.
- The division has not heard any word on getting additional funding for in the increased number of students and staff at The Centre for Learning@HOME.

- The new principal at Christ The King Academy is a long time Brooks teacher, Cindy Freimark.
- Reviewed Board Highlights analytics.

Associate Superintendent Kilcommons reported on the following:

- CTR Catholic is currently transitioning to the Alberta Risk Management Insurance Consortium. Due to the floods in High River, CTR Catholic is considered a higher risk.
- At a recent Local Authorities Election Act meeting he learned that nominations will open on January 1, 2021, and school divisions now have the capability to pass a by-law to allow nominations to be accepted in other communities.
- CTR Catholic budgeted for a deficit of \$495,000 in the year 2019-2020 but expect to finish the year at a break even position due to receiving overdue grant funding from 2015 portable classrooms.
- In March CTR Catholic submitted their projected enrolment and in May submitted a budgeted deficit of \$295,000. This is CTR Catholic's official budget and will not be resubmitted. In the event of an accumulated surplus from 2019-2020 it is recommended that a portion be allocated to support off campus activities and outdoor activity resources as schools are finding challenges around physical education space due to COVID restrictions.

Associate Superintendent Behm reported on the following:

- September/October statistics for teacher and support staff absences.
- Presented the Liaison Committee meeting Board and teacher topics.
- On November 1<sup>st</sup> they will be hosting a retirement planning session via Zoom for all teaching staff. Associate Superintendent Behm reviewed statistics on teacher retirements since 2018.
- Reviewed a failure to fill report regarding substitute teachers with the majority being in the Brooks' area.
- The human resources department has been querying Okotoks substitute teachers to see if they are willing to drive to Brooks to substitute.
- Reviewed what would happen if an active substitute teacher in CTR Catholic has to self isolate.
- Parent teacher interviews in November will either be face to face with significant risk mitigation strategies or via Zoom.

12.02 Program Review – Transportation

Superintendent Morrison reviewed a draft transportation department survey derived from an older department review survey to which they added items that evaluate the department, as opposed to just the carrier. Superintendent Morrison advised the Board that they would have to choose between either hiring a consultant or sending out an independent survey for their evaluation purposes. Associate Superintendent Kilcommons presented names of possible consultants who would be qualified to do the review. Discussion followed and it was the will of the Board to hire a consultant to carry out the transportation department review. Superintendent Morrison will propose what gets evaluated and bring to the Board for approval.

12.03 Major Capital Project Review and IMR Update

Associate Superintendent Kilcommons noted that Director Lunn will talk about last year's Infrastructure Maintenance and Renewal (IMR) and will address the one-time Capital Maintenance and Renewal (CMR) budget stimulus announced last May. Associate Superintendent Kilcommons advised trustees that in the future there is a probability that the government will move to CMR so divisions will not know how much money they will be

receiving, which will require fast planning on CTR Catholic's part. As well, there will be no contingencies when projects go over budget.

Director Lunn highlighted IMR projects for the fiscal years 2019-2020 and 2020-2021. Director Lunn then reviewed CMR projects completed for the fiscal year 2020 and anticipated for fiscal years 2021-2024.

Associate Superintendent Kilcommons thanked Director Lunn for the impressive work he has done with coming up with a plan for the CMR funds and carrying it through.

12.04 Capital Priorities

Associate Superintendent Kilcommons said that the submission date for capital priorities to the government is the end of January. Currently CTR Catholic's priorities are as follows:

- 1. D'Arcy Ranch/École Good Shepherd School project, the "Okotoks solution" which consists of demolishing or modernizing École Good Shepherd School and building a new school in D'Arcy Ranch.
- Expansion of Our Lady of the Snows Catholic Academy in Canmore or a new school site.
- 3. A high school in High River.

Associate Superintendent Kilcommons will share the division's 10-year plan when submitted later in the year.
