#### 2 FOUR-YEAR EDUCATION PLAN

2.01 Catholic Education Program Review - Update

Associate Superintendent MacDonald introduced consultant Jennifer Woo. Ms. Woo noted that she was grateful for the support given throughout the review, particularly for the preparation work that administration and staff did in advance. Ms. Woo provided an overview of her report which was based on the five marks of Catholic School Identity: Mark One: Grounded in Christian Anthropology; Mark Two: Catholic Worldview; Mark Three: Faith Infused Curriculum (Faith Permeation); Mark Four: Gospel Witness (Living a Christian Life); and Mark Five: Spirituality of Communion (Building Community and Unity). In each Mark, Ms. Woo's findings were that the quality of Catholic education at CTR is outstanding, and everything that happens in the schools reflects the collaboration between schools, parishes and the diocese. Ms. Woo did provide suggestions in each Mark as well, in which Catholic education could be deepened. Ms. Woo was thanked for her outstanding work.

Associate Superintendent MacDonald advised that Ms. Woo's report would be reviewed with administration and staff in May. Director of Catholic Education, Grant Gay, will be reviewing the report with faith leaders and targeting four areas in particular: 1. Faith formation; 2. Catholic social teachings; 3. Re-engaging in school-based retreats; and 4. Refocusing on faith, central to who we are and how actions can spread the gospel.

Trustee Gustafson acknowledged the work being done by administration and teachers in all schools that resulted in this positive report being produced.

### 3 BUSINESS ARISING

3.01 Program Review – Technology –Central Office

Deputy Superintendent Behm advised that the technology consultant is scheduled to meet with CTR staff the week of May 15<sup>th</sup>. It is hoped that all work will be completed by the end of June with the final report ready for presentation to the Board in September or October.

3.02 Modernization of Holy Cross Collegiate / Sacred Heart Academy Superintendent Morrison followed up with the Ministry given no response had been received to CTR's request to spend capital funds on the modernization of Holy Cross Collegiate and Sacred Heart Academy in Strathmore. Dr. Morrison was advised that a response is in progress.

**Safe and Caring:** Secondary schools are building culture, morale and spirit within their schools. Both JPII and HTA recently held very successful student-hosted open houses. St. Francis recently sparked teacher and student interest by offering new complimentary courses for next year.

**Stewardship**: St. Mary's Principal, Brandon Bailey, has been named as the recipient of the Distinguished Leadership Award from the Alberta Council for School Leadership. Individuals recognized with this award are considered to be role models with the capabilities to lead innovative change.

9.01 ASBA Zone 5 Report

Trustee Gustafson (Okotoks) advised that ACSTA will next meet on May 25 and 26, 2023.

ACSTA distributed a survey to each provincial Board of Trustees to be completed in preparation for their AGM. Trustees took the time to discuss and answer the questions collectively.

Trustee MacDonald (High River) advised that Zone 5 met on April 14, 2023. Items discussed include the following:

- Alberta Education reported that: 1. the removal of the mandatory entry level training for bus drivers should bring good news to provincial boards; and 2. \$3,000,000 has been allocated to the relocation of the Louise Dean School.
- The ASBA Edwin Parr Awards Zone 5 Ceremony is on May 18.
- CSBA congress registration is open and closes June 2<sup>nd</sup>.
- Potential resolution could be forthcoming at the SGM that trustees should have vulnerable sector checks.
- On May 1<sup>st</sup> there will be a speakers' corner presentation regarding racism and inclusion in school systems.
- ASBA has received two position statements. The first is from Rockyview Schools on school diploma examinations. Superintendent Morrison advised that the senior team had reviewed the statement and they are recommending not supporting it. Reasons for this recommendation include the fact that the Ministry likely conducts an annual review already, and administration believes that diplomas provide students with opportunities to learn how to take tests. The Board agreed with this recommendation.

The second position statement is from Prairie Land Public School Division with respect to recognition of valid teaching certificates. Deputy Superintendent Behm advised that CTR has not encountered difficulties in this regard but given that this change could alleviate difficulties for other divisions, administration was in support of this statement. The Board agreed with this recommendation.

Chair Keenan (Foothills County) reminded trustees to identify one feature per Superintendent report for the April Board Highlights.

Superintendent Morrison reported on the following:

- The Four-Year Education Plan is due to the province at the end of May and will be presented to the Board for approval at the May 23<sup>rd</sup> meeting. Administration has been tasked with updating the strategies within the plan. It was noted that the division is not adding any new initiatives so no new strategies will be added. This is intentional given feedback heard at Superchats to maintain the current focus and to not add any new items. The school-based plans will align with the division's plan.
- Dr. Morrison reviewed the transition plan for the incoming Superintendent.
   To assist with this, he has created a resource document for the incoming Superintendent and will spend the appropriate time needed for training.
   The process for announcing any new hire was reviewed for the benefit of the Board.
- St. Francis of Assisi is 100% full. Accordingly, the need for more modulars is critical for the next three years. An application has been submitted for two modulars, and it is anticipated that more will be needed.

It was the will of the Board to highlight feedback heard at Superchats (re: maintaining current focus and not adding new initiatives) from Superintendent Morrison's report in their April Board Highlights.

- The Aspiring Leaders II Session with Holy Trinity Academy's Vice Principal, Darren Dornstauder, was recently held. Mr. Dornstauder provided information on what he did as a teacher that led him to a leadership role. Attending teachers were passionate in their participation. This Aspiring Leaders Program has fostered many of the division's vice principals, principals, and division office administration.
- Several CTR staff have been recognized this past month, including four first year teachers recognized at CTR's Edwin Parr Awards ceremony on April 25<sup>th</sup>.
   Principals Brandon Bailey (St. Mary's School in Okotoks) and Paulette Chotowetz (Sacred Heart Academy in Strathmore) are recent recipients of the Distinguished Leadership Award.

It was the will of the Board to highlight Aspiring Leaders Program from Deputy Superintendent Behm's report in their April Board Highlights.

Associate Superintendent MacDonald reported on the following:

- Superintendents and Trustees attended six Superchats since the March Board meeting. Feedback from school staff on reputation, areas of improvement and advocacy was shared with the Board. Trustees expressed their appreciation for being able to attend Superchats, which is new to the Board this year.
- CTR hosted the Young Authors' Conference on April 22<sup>nd</sup> for Grades 4-12 students in conjunction with Foothills School Division. The day began with a keynote speaker and was followed by three student-selected sessions. Trustee Gustafson was in attendance and thanked all staff and students for their work in putting on a hugely successful day.
- The Spring Council of School Councils meeting will be held on May 11<sup>th</sup>. Attending the meeting will be the school council chairs from each school. The meeting will include recognition of 10 parents nominated for the St. Joseph Parent of Distinction Award. Trustees are also invited to attend and will make the presentations to the Parents of Distinction. The other focus for the meeting will be to engage school council chairs in conversations as parents as partners in Catholic education.

It was the will of the Board to highlight Superchats from Associate Superintendent MacDonald's report in their April Board Highlights.

Associate Superintendent Kilcommons reported on the following:

- The new funding for student transportation changes rider eligibility for Kindergarten to Grade 6 to 1.0 km and Grades 7-9 to 2.0 km. Divisions have been given a year to phase the change. Bus and driver shortages could pose difficulties in fully implementing this change. Corporate Services will meet with Southland Transportation next week to work on plans in the hopes of accommodating all riders.
- It is anticipated that the next couple of years will be a busy time for the Facilities Department with construction. This includes the building of the replacement school for Ecole Good Shepherd School in D'Arcy Ranch which

is anticipated to be completed by September 2025 (best case scenario) or September 2026 if complications arise. The modernization of Scared Heart Academy and Holy Cross Collegiate in Strathmore and emergency modulars at St. Francis are also pending provincial approval. The province has also requested that a site readiness checklist be completed for the expansion of Our Lady of the Snows Catholic Academy in Canmore, which is encouraging, but does not mean the project is approved. The capital plan and infrastructure maintenance report have also identified many projects which will make for an extremely busy summer.

- CTR has received official confirmation of \$250,000 to build the new playground at the Ecole Good Shepherd School replacement school in D'Arcy Ranch.
- The Alberta Summer Games will be hosted in Okotoks and Diamond Valley in July. CTR's traditional school in Okotoks will be utilized for temporary housing with food and cots being supplied by Alberta Games. Likewise, several facilities will be utilized as sporting venues. This is a tremendous amount of work, and David Lunn, Director of Facilities, was recognized in this regard.

It was the will of the Board to highlight the work being done and upcoming for the Facilities Department from Associate Superintendent Kilcommon's report in their April Board Highlights.

13.03 Draft Budget Review

Associate Superintendent Kilcommons provided an overview of the draft budget. The finalized budget will be presented to the Audit Committee on May 17<sup>th</sup> and then to the Board for approval on May 23<sup>rd</sup>. The approved budget will then be sent to the province no later than May 31<sup>st</sup>, 2023.
