2 BUSINESS ARISING

Superintendent Morrison is pleased that CTR could facilitate this workshop for the benefit of all divisions.

This meeting will be held in follow up to the Deputy Minister's visit to the school in March. No further influence has been received to move forward with gym project.

Faith: All schools reported high satisfaction with the ability to host in-person faith experiences such as Shrove Tuesday breakfasts, Ash Wednesday liturgies, and the upcoming Holy Thursday celebrations.

Learning: The principals all reported that teacher teams continue to follow through using high impact strategies as part of their Praxis plans.

Safe and Caring: There has been amazing energy in the schools with a return to so many activities we may have taken for granted in the past, including live parent-teacher interviews, book fairs, hockey games, sports, assemblies, awards ceremonies, band and drama clubs/retreats, and clubs (the Paper Airplane Club at St. Mary's is unique!).

Stewardship: St. Mary's has two innovative programs in the works for next year. Both are aimed at meeting student and parent needs. The first is a pre-kindergarten program and the second is before and after school care. Early interest in both programs has been very encouraging.

Superintendent Morrison reported on the following:

- Issues Management a three-step process for dealing with issues was reviewed. This is a helpful tool for both trustees and administration when dealing with contentious issues, concerns, or complaints.
- A before and after school care program will be piloted next year at St.
 Mary's and at Holy Spirit. Similarly, a pre-kindergarten program will be piloted at St. Mary's. Registration for these programs is encouraging.
 Learning Services Coordinator, Tara Epp, was commended for her efforts in getting these programs started.
- To enhance CTR's social media presence, a communication lead position at each school will be created. The communication leads will receive training and will work with the school's principal and Communications Coordinator Cindy Nickerson.
- Pursuant to the Board's motion last month to open Okotoks attendance areas, 12 requests for existing students to change schools have been received as well as seven requests from new students. It is expected that these numbers could increase before next fall.
- Superintendent Morrison has been contacted by the Minister's office regarding the Calgary Board of Education's request to expand their boundaries to match that of the City of Calgary. Superintendent Morrison reiterated the Board's position previously provided in that there should be a process to consult members of the electorate before taking a formed area away from a Catholic Board.

It was the will of the Board to highlight the before and after school care and prekindergarten pilot programs from Superintendent Morrison's report in their April Board Highlights.

Deputy Superintendent Behm reported on the following:

 The benefits of NCCS – as fluctuations are still being experienced with staff absences, non-certified classroom supervisors are being utilized for coverage when substitutes are not available. This initiative has significantly reduced the amount of internal teacher coverage needed.

13.02 Superintendents' Reports

- Staffing templates have been developed to assist administration with staffing.
 These templates set out formulas for staffing to student ratios ensuring that
 that there is consistent and sufficient administrative, learning support,
 teaching, educational assistant, and support staff in each school.
- CTR retirement/leaves/resignations/recruiting information on these leaves
 is collected and provided to administration in November of each year. This
 allows HR to be proactive in filling positions ensuring appropriate coverage.
- Employee recognition the recipient of the Edwin Parr Award, Belinda Ziehl, was recognized at a ceremony held on April 25th along with the other first-year teachers nominated. Deputy Behm applauded each nominee for their tremendous efforts and the passion they bring to teaching.

It was the will of the Board to highlight the Edwin Parr nominees from Deputy Superintendent Behm's report in their April Board Highlights.

Associate Superintendent Moss reported on the following:

- Grant Gay will be starting as the Director of Catholic Education effective May 13, 2022. Mr. Gay has a theological background, and this combined with his past experiences, will make him a strong member of the senior administration team.
- Administration and Trustee Retreat trustees were reminded of the retreat being held on May 11 and 12 and were asked to confirm their attendance and registration details with Director of Catholic Education, Lindsay Avramovic.
- Curriculum update Associate Superintendent Moss and Director of Learning Cheryl Kuemper continue to work with principals and teachers on the plan for new curriculum implementation given the curriculum release from the Ministry. Consultation with principals is currently underway as to teacher interest in proceeding with piloting of the new math curriculum in grades 4-6 in 2022-2023. Curriculum Support Documents for this curriculum will be finalized in June 2022. This early implementation would lessen the workload in 2023-2024 when new curriculum for grades 4-6 English Language Arts & Literature and Science is also due for implementation.
- Covid update schools continue to monitor student absenteeism, which for the month of April is up 1% from March.
- Superchats were recently held at Notre Dame Collegiate and St. Mary's School. At both Superchats, teachers expressed their thanks to the Board for the time in lieu provided with the cancellation of CLCs and shortening of Faith Days. Superintendents also heard that Notre Dame currently has a program in which dogs are brought in to sit with students while they read. It has been highly effective at improving student wellness. At St. Mary's, Superintendents heard that some elementary students are experiencing a delay in social skills given the pandemic. Situations are dealt with as they arise as they provide excellent learning opportunities.

It was the will of the Board to highlight the possible early piloting of the new math curriculum for grades 4-6 from Associate Superintendent Moss' report in their April Board Highlights.

Associate Superintendent Kilcommons reported on the following:

Potential capital expense – Sacred Heart Academy and Holy Cross Collegiate
in Strathmore are currently sharing space which is less than ideal. Funds are
not available for additional space through the capital budget, however, CTR
received funds for flood mitigation at Holy Spirit Academy and Notre Dame

Collegiate which were in excess of what was needed. Application has been made to the Ministry requesting that these surplus flood mitigation funds be made available to assist in alleviating the space issue for these two schools in Strathmore.

- Insurance is currently provided by Alberta Risk Management Insurance Consortium ("ARMIC"). This is a recent transition from insurance with Alberta School Boards' Insurance Exchange ("ASBIE") which is now winding down. The contract with ARMIC is annual and the province is providing a backstop for claims in the amount of \$15,000,000 until November 2023. ARMIC provides outbound travel insurance for international trips in the premium paid and insurance for facility user (at a minimal additional cost). It is expected that premiums may increase next year. However, it was also noted that in 2023 the flood of 2013 comes off the insurance history.
- Potential multi-sport feature CTR is currently in consultation/negotiation with the Town of Okotoks for a multi-season outdoor sports rink at St. John Paul II Collegiate. The school will have full access to the rink during the day and the Town will be responsible for liability, maintenance, and upkeep.

It was the will of the Board to highlight the application to the Ministry on funding for additional space at Sacred Heart Academy/Holy Cross Collegiate in Strathmore from Associate Superintendent Kilcommons' report in their April Board Highlights.

13.03 Draft Budget Review

Associate Superintendent Kilcommons provided a preliminary budget review in preparation for the final budget review. An explanation of weighted moving average was provided. The calculation of the weighted moving average can be difficult, but administration goes to great lengths to get it as accurate as possible to ensure proper funding.

The budget will be presented to the Audit Committee in May and will then be presented to the Board for approval at the Regular Board Meeting scheduled on May 26, 2022.
